WV Resident Breeder

- o Mares must submit a WVTBA Resident Mare Form and be on the Resident Mare List by January 1 of every calendar year.
- o The owner or Farm manager must contact the WVTBA office or the WVDF Inspector to schedule annual inspection. If mares leave the farm of residence, the WVDF Inspector must be notified.
- o A new mare that is in foal must get an affidavit 30 days prior to foaling from the WVDF Inspector.
- o All breeders listed on Jockey Club papers must be WV residents, or the bred back clause applies.

Out of State Breeder

- o Mares who are not on a resident mares list and do not reside in WV year-round must follow the bred back clause.
- o Must have an affidavit within 30 days of foaling
- o If Mare resides in West Virginia year-round, the above criteria can be followed
